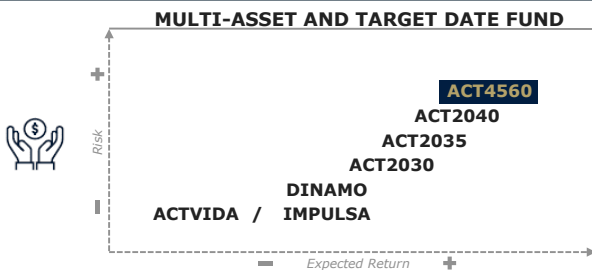
1. Target Date Fund, for individuals reaching 65 years (retirement age) beyond 2040.

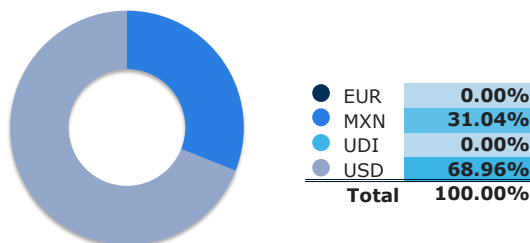

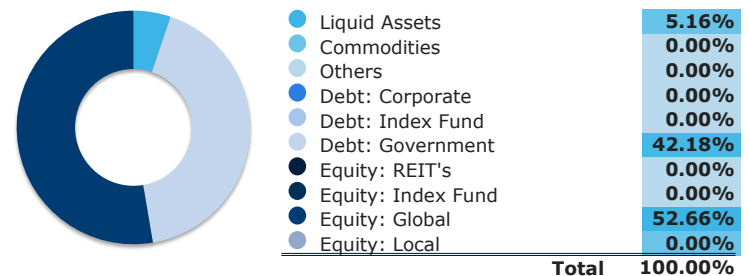

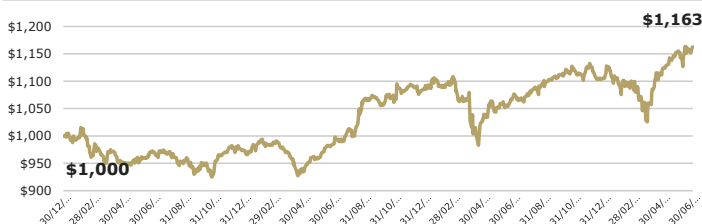
CURRENCY BREAKDOWN¹



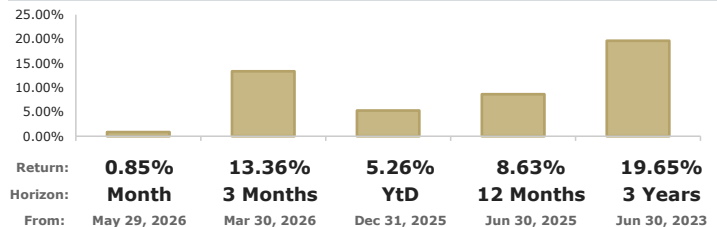
ASSET CLASS BREAKDOWN¹
