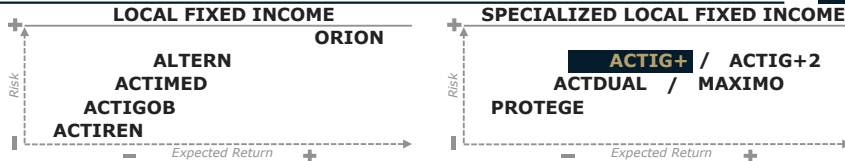
Medium-Term Fixed Income Fund, Low-Moderate Risk Profile and annual sales (early redemptions allowed with penalty).

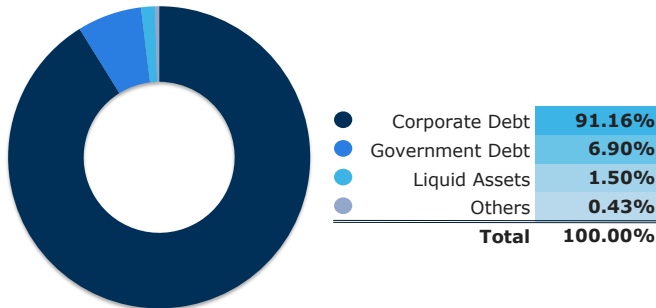

## ASSET CLASS BREAKDOWN<sup>1</sup>



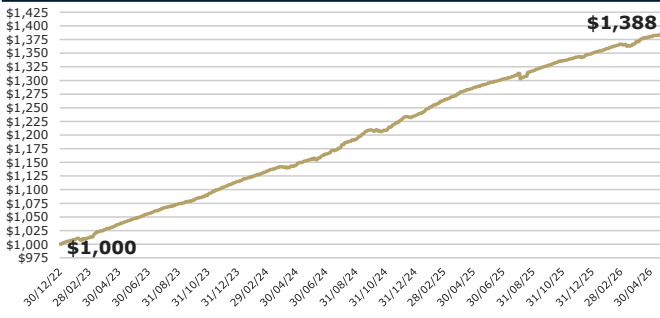

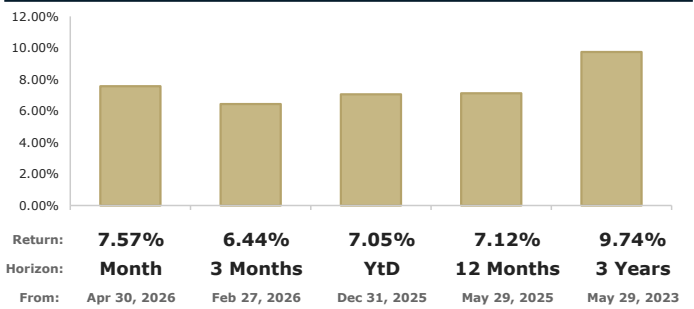
## CURRENCY BREAKDOWN<sup>1</sup>
