FUND KEY ASPECTS



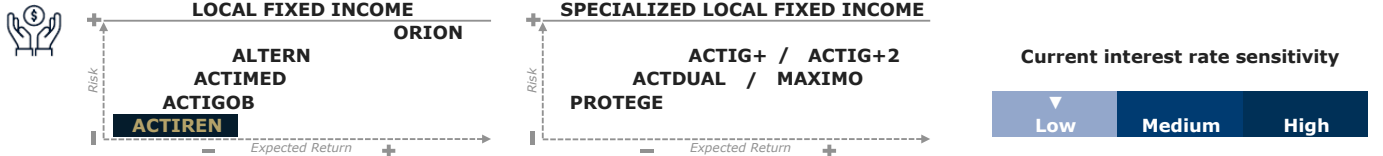
1. Fund's objective is to provide liquidity with low volatility.

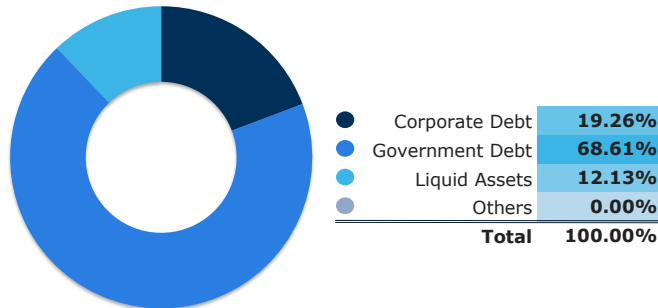

ASSET CLASS BREAKDOWN¹



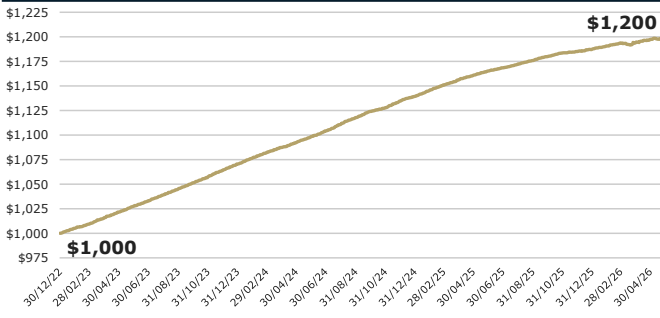

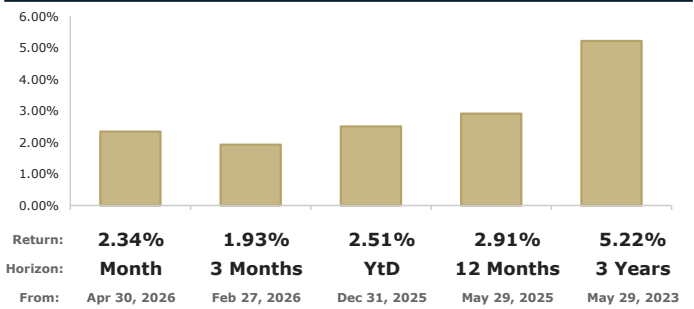
CURRENCY BREAKDOWN¹
